Taking Our Country Back

Prior to 1871, our nation was known as the united states of America. Joined states, as listed by the Constitution's framers in uniting the 13 states that had been formed at the time of its signing: New Hampshire, Massachusetts, Rhode Island, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina and Georgia.

A Conversation between CaptKyle and Robert Craft

May 3, 2025

The following information was gleaned from an audio recording created bye Captain Kyle, Kelly of CaptKyle Patriots ® and Robert Craft of Our United Republic which are Telegram channels created and promoted by Captain Kyle and Robert Craft respectively. Mr. Craft also endorses the American National Organization for rebuilding American Communities and assisting Veterans who have been abandoned by the those bestowed duty, but are failures. CaptKyle: Good evening everyone and welcome to the "End Game." It is Captain Kyle and we have Kelly, and we have our special guest Robert Craft and he is with Our United Republic, and so you know we were talking behind stage just a minute ago and basically I was trying to figure out whether or not Robert considers me a friend or not because he's talking to me not talking to me and we're going to take a long walk in the woods or whatever you like that huh I was like you know (laughs).

You know are we friends, not friends, I don't know so anyway, I'm just kidding. We were actually getting into a lot of really good stuff that we're going to talk to you about because I already know we are so that's all good and so because we are on the same page maybe we have some different understandings about stuff, but that's where we plug in things because he knows things that I don't know and I know things he doesn't, know, necessarily know, and those kind of things work together. That's how we figure things out, is coming together. We're talking about these things, right? And so, but before we get started, we're going to pray.

Dear Heavenly Father, thank you for today. Lord, I just thank you for all you're doing. And Lord, I know that you are in control of all things. Lord, I just ask that you bless each and every one of us. Lord, bless this call. Bless the people that are on this call. Watch over and protect them. Keep your hands and arms stretched out to each and every one of us. Lord, I ask that you pour out your discernment upon your people so that they can understand those things in which we're trying to disseminate in this world, Father, because we're trying to figure these things out. Lord, we thank you that with your Spirit, we can figure all things out because you can lead us and guide us into those truths. Father, we thank you for it. We praise you in Jesus' name. Amen.

All right. So, we got Kelly, we got Robert, we got myself, and we got... information. So, all right. So, how you been doing, Robert?

Robert: I've been busy. It has been a lot, but there's a lot of, it's almost like a sea of information has been opening up for the last couple of weeks. I took a trip to New York and I learned a

massive amount about how our law system works, specifically, jurisdictionally, it changed really everything. And then I took that trip out to Colorado and Kansas. I got back a couple of days ago. And again, man, just, and then I've been in contact and we've really lasered down and figured out, we have got a strategy, a plan, we've got a location, a what, all we need is, we got a wear, all we need is a when, and a capacity, and this thing's going down, so it's been really, really exciting, especially for the last week.

CaptKyle: So, I remember you saying, a little while back, since the last time we talked, because, you know, I did, it's been a little while, it's been a minute, because I kind of went through an episode where they tried to take me down, and it didn't work, and praise be to God, so, you know, it's good to be healthy, and it's good to have God on your side, and they always screw up, they always do, and so, it just makes it to where, it just makes it just that much sweeter, it does, actually, and it's not the first time, it's been actually multiple times, that they've actually tried to, but it's all, you know, it's all good. And the last time I remember you talking about, I put some stuff out about putting a pause on things that people were doing individually to try to work towards establishing, you know, their communities and trust and so on, stuff like that. And, and then where we're at today, a lot of stuff is going on and, you know, there's a lot of financial things that are happening within the country, there's a lot of lawful things that are happening behind there. And that's kind of where, you know, we're going to talk about both of those things. And even with the financial part of it, there's multiple sides to that, actually. And those are things we're going to get into. We'll get into some of the other stuff that's going on with, you know, the globalists. You know, stuff that's happening with Israel and everywhere else, but most of that's setting the stage for them to basically take their own self down and out. And anyone that's lining you up that we're being a puppet towards all that, you've lost your freaking mind. I got news for you. That is not the case. But in the past, the United States was actually the puppet for Israel. I just want you to understand that.

Robert: Oh, we've been the puppet way more than Israel. Way more than Israel.

CaptKyle: The Jewish in the whole situation. But that was not necessarily the Israel of the Bible. That was the Syrian freaking corrupt, evil freaking banking cartel that actually established that through the Rothschilds. And so all of that's going to come out in the wash. But anyway. Anybody's playing that Trump and the military and all that, we're being puppets to Israel right now and all that, No, you're trying to set up a division and you have no fucking idea what's going on. So shut up. How about that?

Robert: I'm not going to argue with that one.

CaptKyle: So, all right. So going on here in the United States, what's going on? Because we've got a lot of stuff that's happening with the financial situation. There's a couple of different things, we have an endowment, there's a trust and different stuff that's actually happening with that. We have a sovereign fund that's actually taking place and the establishment to the Treasury

Department and all that kind of stuff, the Fed people, it doesn't exist anymore in the way that you think it does.

Robert: Correct.

CaptKyle: It was consumed by the Treasury Department a long time ago. Just plain and simple.

Robert: simple yeah well the funding authority has been basically restructured and limited far greater than it ever was so yes that's the first phase, remember we have a second phase because the assets have to be returned that to be all about that they have to all be back in the Federal Reserve no right claim they have to have a place to go. (CaptKyle: yeah.) Right now there is no American National Republic there is an America, in the Gulf okay? But that America, (CaptKyle: yes), that's why this is why it was named this is the reason it was named that it had to be named America because now America that is that is inhabited, Indigenously inhabited because the USMCA treaty recognized indigenous, so indigenously inhabited has to be what's called settled, so we need a settlement, Okay, remember thinking about Massachusetts Bay Colony. You got Massachusetts Bay. (CaptKyle: Yes), they have the Mayflower Compact. That is the settlement. Those are the base rules for the settlement and then eventually as it grew it went to Boston Harbor. Boston Harbor is where the Navy can make port. Massachusetts Bay is where the Coast Guard makes port, Okay? So Coast Guard does not operate in harbors Coast Guard operates in bays, the Navy makes port in harbors and that's one of our problems. We don't understand and I didn't learn this. I took a trip to New York, two weeks ago, I went to, So, Brooklyn is in King's County. It is in the borough of Brooklyn. Okay? And that is the actual Grand Jurisdiction. So, when you say Grand Jury, that is the place where the grand jury begins. Okay? The reason is because King Charles granted Brooklyn, King's County, as the seat of government is called *sui generalis*, which means a thing among of itself, which means it has the ability to produce any type of Jurisdictional Trust. So, when I was in the library in Brooklyn, at the Supreme Court of Brooklyn, found the original books for generating Guam, generating the U.S. Virgin Islands, generating the Philippines, generating, I found a book called American International Law Process and Procedure for Human Rights and Arbitration and the Law of the Sea in that library. So that is where it is, but that is just the Grand Jurisdiction. And because it's there, it can be originated out of there, but you still have to get it out of there to other places. Does that make sense? (CK: Yes, absolutely.) So what we found out was boroughs are very important. Boroughs are on the North American continent. Boroughs are the railroad system. Boroughs are the subway system. Boroughs are the transatlantic, continental system, the shipping system, the actual harbors and the ships and the Navy is how that stuff is conveyed.




Location of Brooklyn, New York

So we are talking about America has to be settled. The mechanism has to be put in place for Gulf of America to meet America on the land, and then there has to be a process, a law process, for that land to now be staked and settled as America.

CaptKyle: So let me go with that right there, right? Because we talked about the Americas and the harbor, and the military, on land taking the stadium, taking the field. (Robert: Yes.) And what, that represented and so where are we, (Robert: they are still sitting there, they're still sitting there. They are still sitting there the port of no American port, they have a U.S port. So the U.S Navy is in control of the ports. Now now we have to get an American port. Okay? So we have to go to the next level, because remember, the United States of America is a country. The United States is a country, so the United States of America is a State Country, right? They call the State globally, but it's a state, but it's a World Trade Country. Makes sense? The United States.

## CaptKyle: Yes.

**Robert**: The United States is a nation state, yes? Right. That is correct. But America is a *people's nation state*.

**CaptKyle**: Okay. So, where did that become disconnected? When did that become disconnected? Because we were that and then we weren't that.

**Robert**: That's right. So America was founded as a People's Nation State, which is technically, a Church, a nation, right? Which is like for defense, stuff like that. Common defense, right? (CK: So like the wall, right?) And then, and then our trade and commerce, which is the State, right? (CK: Yeah. Because they only had like three roles.) Well, it's a trinity, there's only three. It goes back, it actually goes back to Plato in the book of Timaeus. In the beginning of the book of Timaeus, they describe a country within a country within a country, or a jurisdiction within a jurisdiction within a jurisdiction, which is mind, body, and soul. So America is the People's Nation State, the United States is a Nation State, and the USA is a State. Okay? So, what happened is somewhere around 1830, the powers that be, now remember, we technically lost the War of 1812. Actually, technically the war with America is still going on, the war with the United States. (CK: It never went, it never died, it just kind of went away.) Well, remember, there's three countries. There's a country within a country within a country. Okay? So America, the Nation State, has never had a peace treaty on the War of 1812. The United States, as a Nation State, signed a peace treaty on the War of 1812, and the United States of America, because it is subservient or the lowest branch or the lowest division in the hierarchy, that obviously has to secure that treaty because it came from a higher jurisdiction. Does that make sense? Okay, that's exactly how it works. Right. So it's hierarchy. So, but America Nation State has never executed that treaty. So that treaty is only with the United States, it's not with America. So what they did somewhere around 1830s, they built another Washington, D.C. Another People's Nation-state inside the United States. And then they proceeded to basically replicate nation-states cutting off the people version. And then they used that replicated nation-state to create nation-states all over the world. Getting rid of all the people.

CaptKyle: Okay, and so if we're talking about this being in the mid-1800s.

**Robert**: Yeah, early to mid-1800s. That's correct.

CaptKyle: And so 1830, 1850, whatever. And then coming into the agreement that gave basically D.C. the corporate construct of three miles squared, not being the nation-state itself, (Robert: right) which was completely outside of the jurisdiction of the United States, (Robert: right) whole it was its own country that only had authority within that three mile by three mile area, outside of it had no jurisdiction typically, and that was the pulling the wool over everybody's freaking eyes that they so so all, so this is what i think it happened is that they had this the the D.C. and then when it became incorporated right jurisdictionally they had their control over that area right and then you had each state incorporate and then incorporate underneath that fucking America-state bullshit because they all subservient underneath it like each state actually went underneath the D.C. corporate.

**Robert**: I think that was true until we got to the Civil War, I think they were able to pull that off until they got to the Civil War, so I don't know that to be a fact. I think you're right because this is progressive. So I think from between the time, the mid to early 1830s when they were replicating these *tri-nation states*, *People's Nation States*, and then they were carving out the second parts

they wanted and leaving the other parts where they were. I think that was true. But I think what happened was, I think when the Civil War hit, I think the jig was up, so that's when this kind of weird transition happened and then after the Civil War with Lincoln gone, because I think Lincoln figured it out, what they did, and Lincoln was trying to, like he was going to blow the top off. They eliminated him, and I think that after the 13th and 14th Amendment were passed, you now had U.S. citizens. Well, there were no U.S. citizens prior to, they were inhabitants, they were not citizens. Now, because now the government was ruled by the Article 4 federal government at that time, which was the federal government. So that government now created U.S. citizens. And that took it all the way up until the end of the 1800s. And the end of the 1800s with the World's Fair, the World's Fair, the end of the World's Fair, the commissioners turned to ash the Statue of the Republic at the Court of Honor in Jackson Park, Chicago. That was the last. event that took place at the World's Fair, which basically was the last remnant of the Republic and the Court of Honor, was gone. Then you have, then you have us, we bind to the Philippines, you have this, this like weird transition that happens, early 1800s, you have World War II, you have the League of Nations that is established that basically was overrun, creating the United Nations, the Hague is established by Andrew Carnegie and Associates, so you have all this stuff that happens early 1800s, which is right about the time where, the War of 1812 Ninety-Nine Year Trust is expiring. So there's this whole transition that goes on right at the early 1900s. So then you get to, you get through like, you now, now line up the wars - you've got World War I, you've got World War II, you've got Korea, and then you've got Vietnam. In September of 1969, within one month, there's an Act passed called the Pan-American Act. That Pan-American Act in the Western Hemisphere declared all courts in the Western Hemisphere as Civil Courts, but what nobody knew was that the federal government that they were saying existed was actually the Philippine-Guam federal government that was agreed to after World War II, after the bombing of Hiroshima.

CaptKyle: Let me ask you this, okay? Because this was all based upon a scam fraud that was committed on to the people.

**Robert**: It wasn't, it wasn't a fraud.

**CaptKyle**:: Yeah, well, it was because, okay, so tell me how that you could actually bring a people from being inside of a Republic and into a corporatocracy and then have no fucking idea that that happened.

**Robert**: Because we were conquered. We lost the war of 1812. We were conquered. We were a conquered people. When the Monroe Doctrine went out, it locked out the Russian American Corporation, and it locked out the English Trading Company, and it locked them all out, and all the American ports were closed, and only U.S. ports were allowed to be used. But those U.S. ports were only allowed to be used from East India Trade Company ports, so that's why they call it The West Indies. So all the American ports were closed.

**CaptKyle**: Yeah, but even at that, we were sold a bill of goods.

**Robert**: But it doesn't matter, because we were a conquered people, so we had no rights we were under United Kingdom and Netherlands, British rule since the early 1800s, since 1814, and by 1819 when the flag that we call the American flag was agreed to by the U.S. Congress, that was a usurpation Congress ,because that is not the national flag. The national flag is a Fort McHenry flag, and the Grand flag (below), which is the Grand Congress flag, which is the the Continental Congress flag, you can't even find that flag, that flag is in the International Trade Center building



in Washington D.C. at the memorial of the of the American Republic, that says, "The Young Republic, 1776 to 1814." Here's the Grand flag, which is the flag that the Marines, when they invaded Nassau, raised on the shores of Nassau when they invaded Nassau, ordered by the Continental Congress. So the flag we're using is a U.S. Usurpation flag. (CK: It's a war flag.) Yes, we are a conquered people. So we are saying fraud without understanding our nation was conquered. We lost. We lost the war. We're not a fraud. We're lied to. That's true. But it was because, (CaptKyle: Well, that actually constitutes fraud in all actuality. I mean, if you're specifically lied to and misled with intent,

that's fraud. I've, I actually got that done in court. I broke a fucking corporate veil and had equally and jointly liable to the other person.

**Robert**: Okay, so let's, make it simple. If you tell your dog, if you say to your dog, do you want a treat? And then you go to the kitchen, there's no treats, and you don't give your dog a treat, does your dog tell you that you committed fraud? That's basically how they look at it.

**CaptKyle**: They may look at it that way, but that don't make it real.

**Robert**: It is if they have the power. It doesn't make it right. It doesn't make it right, but it does make it real.

**CaptKyle**: Because that's the hard thing. It's always about intent. (Robert: It is about intent.) It's intent. The hardest thing to produce in a fraud case, and they'll tell you that right off the bat, is intent. Right, you get it. And that's where you have to practically produce intent.

**Robert**: Because there's no Seventh Amendment court to have the fact declared. Then it's easy to produce. Why? Because a trial by jury under the Seventh Amendment said it was a fact in law. So guess what? I don't need to play the song of intent. Right here it says, you did it. Okay, that's why they don't want those Courts. That's why those Courts won't declare facts. Because only, only an American Ministerial Court at the Seventh Amendment can declare a fact in law. And we don't have them. We don't have them.

CaptKyle: Okay, so how are we at this point, where we're at right now? Because we're under military law whether people realize they're not. I can just tell you that.

**Robert**:: We are. Yeah, yeah. The martial law is more.

**CaptKyle**: And this is where it's like, when Trump actually starts to tell the public that they're potentially thinking, about, you know, suspending habeas corpus and stuff, and it's like martial law. No, people, you're already under it, I've been telling you that for freaking years.

**Robert**: No, we are. We're actually not. We were under Federal Martial Law. We are actually now under our U.S. Military National Martial Law. (CaptKyle:: Yes.) Which is better, which is better because the ability to issue federal FISA warrants are actually divided between the agency that's seeking the warrant and another agency that's saying, yes or no, that's a legitimate warrant, that's not. So at least that power has been divided, which is good. That's a good thing. That also means that the warrants that they're issuing that are FISA warrants are probably more legitimate warrants, which is why you're seeing judges arrested. You're seeing like people who are running foreign nefarious NGOs are getting arrested, right? So there's like real arrests. (CaptKyle: I mean, they just said, wait till you about to see what's about to happen, because there's a lot of people that are about to start getting arrested, whether people like it or not. It's going to scare the shit out of people.) So, so there, but if you notice, they are focusing on people who are either influential, or they have some kind of authority, or they have a duty. Yeah, you got to get rid of, you got to fix the judicial part of that. So they're not, so they're not, if you notice, if you notice, they're not messing with like the average public, whatever regular person that's walking around, going to work, doing their thing. Yeah, they're, they're, care about them. They care about the people who are committing fraud, corruption, theft, the human trafficking, all this stuff, right? All the real stuff. The real stuff that everybody's really, really, really pissed about is what they're focused on. Well, guess what? That's what we want them to focus on. Leave the average person that is going to work trying to make ends meet alone. Deal with the douchebags. (CaptKyle: Yeah, and that's how it is. And if you didn't do something severely criminal, then you really don't have nothing to worry about.) That's exactly how it is. But if you have power, you have responsibility, you better check yourself. You better check yourself. And this thing, so here's the kicker. They can do it at a Federal level, and they can do it at a National level, but they have not reached the County. They cannot get to the County unless it's an extenuating circumstance with a chain that directly links that County to something else that they can find their way through, right?

**CaptKyle**: And there is, because all you got to do is go to the COVID.

**Robert**: But I'm talking about overall. I'm talking about overall.

CaptKyle: They can't like... (Robert: Yeah, yeah, yeah.) Yeah, no, but all you got to do is go to that, and you got humanitarian, and basically crimes against humanity all the way down to the freaking nurse.

**Robert**: Well, that doesn't happen until you get to International Law, and International Law, which is Common Law, can only happen in America.

CaptKyle: So this is where we're headed, people, and this is why we're having this conversation, because this is a lot of stuff that's going on right now behind the scenes, and you're not understanding all of the bells and whistles that are at the gears that are having to be manipulated to make all of this stuff happen. It is very difficult, but it is all being played out. Okay? So all right so let's go from where we're at right now with what we've been talking about to how are we supposedly making this transition because I know that you basically had told people that they needed to put a pause on you know what they were trying to do locally so to speak until some that you had better direction as far as that goes.

**Robert**: So interestingly enough, (CaptKyle: I want to make the transition now and I want to get into like even what we talked about earlier about the different White House are different whatever.) So here and and a lot of this, I mean like you can call it divine intervention, you just say there's a guy you say something, I, I pretty much don't question any of it anymore. I've had too many weird things happen to discount anything, I'm just in the game making decisions, but here's where we are - we have found the location where the actual event, the actual Continental Congress for the American National Republic has to meet. We know the site. We know the area where that goes down. We have pretty much locked down 70% of who has to be there for the event to take place. So we know that. They left, when they did this whole thing, they left a wide open door for that to happen. Okay? So we are, so right now what's happening, there's a couple things going on, uh, when we found this out and we have been moving forward so I have, I'm an incident management guy, Nationalist Management System, so right now we have a Financial Officer, we have a recorder, a scribe, we call her The Archivist, uh Patty Cummings-Hatfield which you've seen videos, she is our Public Information Officer, and we are setting up right now to find the organization, the national organization, that is gonna be the, basically the the public's carrier to ride this care on this platform that's gonna that's gonna make landfall into America. Right? So I contacted the America States Assembly, um, after enough conversation I decided that they are not going to be, they're just they're just too there's just too much conflict, too much argument too much blah blah, that is not so they're out so American States Assembly's out, we're not taking them, uh as far as a national organization, uh we are in between two others that we're looking at one of them we've asked to do to make some concessions and reform themselves a little bit, their State level organization is actually complying and they are moving very quickly to reorganize their State into uh into the system that's most effective. There's another organization that's possibly going to come into affiliation and assist, but it has to, be structured in a very linear certain way because there's other things that have to happen the convention. So we're working on that part. That is the public side of getting people organized properly and getting those public hearings ready to go and done before the event actually takes place. On the actual landing side, we have figured out, as far as the Military goes, we don't need anybody from the Military except the representatives for the Judge Advocate General Corps of each branch. They will assume the judicial side of this. So other than the Judge Advocate General Corps, no higher than Colonel, that are going to sit and actually stand at convention, we don't need anybody else there. We do not need any Flag Officers. We do not, because Flag Officers are International Officers, they're not American. They're not American. They're actually

International Chambers of Commerce, so they fall under the International Chambers of Commerce so they're not actually American Officers which should go above Colonel or 06, so, but we do need the Judge Advocates to hold the Judicial branch of that. We have figured out, because the Pope has passed, at state, whatever the procedure is, because they signed a Treaty in 2022, we need a representative from the Vatican. We need a representative from Islam. We need a representative from Judaism and we need a representative from the Greek Orthodox Church. So we need those four because they are very specific in their Jurisdictional Authority, that they're not there to represent their religion, they are there to represent the accepted jurisdiction, that is theirs. Does that make sense? And that jurisdiction is called universal jurisdiction. So they are not there as their religious representative, they are there for that particular jurisdiction, that's right here. That's it. The judge advocates are at the International Jurisdiction. Right there. That's it. So everybody that's there is playing a part in assembling this amalgamation and everybody there has an offering, they have something that they bring and when they bring that, they are not only agreeing, they are consenting, they are sponsoring everybody else in their current form. Okay? Because when the hearing happens and they all are in one room and that hearing starts and they all rise. They rise as one, and when they take their seat, the entire jurisdiction jurisdictions that are represented there are unified in one place at one time. Does that make sense?

CaptKyle: Yeah, I'm trying to still.

Robert:: So, you're not, right, so you're not, so we, because we have a national, we have an international, we have a global, we have a universal, we have a space jurisdiction, we have a equity jurisdiction, we have an admiral jurisdiction, we have a maritime jurisdiction, we have a community jurisdiction, we have a, like, veteran sponsored, every branch, it has to be that part and they bring different parts, like, so this is an amalgamation of representation. (CaptKyle: Right.) And all these little pieces of the, puzzle, make the whole. And when they make the whole, that is where the American National Republic and all of its jurisdictions, all united, become the People's Nation State in Convention. And then we deliberate the details of the jurisdictions. Who's going where? The Marine Corps are no longer under the Navy, they are being moved back to Maine. They are going to have their divisions in America. This is how it's going to go. The way it was, the way it was supposed to be. This is going to go here. This is going to move here. What are we doing with this jurisdiction? We're going to move it up. We're going to flip it around. It didn't work the last time. And then when that's done, and all members sign, that is the organization, consecration, ordainment, consecrated American National Republic, a People's Nation State, whole.

**CaptKyle**: Okay, so from that, how do we move into establishing... (**Robert:** The financial stuff, right? The financial stuff.) Well, yeah, that's part of that, right? That's actually another whole freaking quadrant of it, but I'm talking about a governmental body that is representative of We The People.

**Robert**: Right, so what will happen from there, what will happen from there, what should happen, what should happen, number one, we want the \$150 trillion trust back in America. Now America's here, so now we want our Grand Trust back, right? (**CaptKyle**: And you know, we actually have...) Well, we do, we do have two. There's one that's the Grand Trust, and then there's one that is the loans that the Federal Government took that they owe.

**CaptKyle**: Yes, because that's what the people need to understand, is that we actually have an endowment of the national parks that are holding all of our minerals and mineral rights underneath our freaking sovereign ground that is worth close to \$150 trillion that they have actually kept from us intentionally.

**Robert**:: No. We never had a national domestic platform carrier to put it on. That's what this is. This sets up the...

**CaptKyle**: I get it, but what I'm saying is that they initially put that under the national parks to keep it out of the people from being able to go in and get it.

**Robert**: No, the national parks are offshore. It can't be used until it's actually domestic and you have a National Domestic Trust. We don't have a National Domestic Trust. that's what this whole process is about is setting up the American National Republic which is the National Domestic Trust. Now you can put it on...

CaptKyle: I get it I now I understand I understand that part now. Okay? As far as how that was.

**Robert**: Right. Because the Trust expired, it had to be moved off...

**CaptKyle**: The other part of that is the actual Bank Trust, which is the money trust that is a part of the National that is always been there and that's why they couldn't nationalize the banks back in 2009...

**Robert**: Because there was no carrier. They couldn't put it anywhere because there was nothing there. So here's what should happen, somewhere, I'm and this is my suspicion because I've been right on a lot of this stuff, what will happen out of that Convention, once we get the preliminary stuff locked down, they will send an Order to the Navy commanding the Navy to go, and I'm pretty sure this is where it is to the Grand Banks, and they will pick up a landmark. That landmark at the Grand Banks is where the Grand Bank is. They will pick it up and they will bring it to Charlotte Harbor in Southwest Florida. When the Navy makes port with the landmark, the Grand Bank jurisdiction has now returned to the land. Right. But it has to happen in Charlotte Harbor.

**CaptKyle**: We're talking about Grand Banks off of North Carolina.

**Robert**: Yes, that is where the Grand Bank is. But Grand Jurisdiction is in Brooklyn, okay, and National Jurisdiction is in the National Harbor, in D.C., so the problem is they have to get out of National Harbor and they have to get to the American National Republic, which means they have to go out of National Harbor, they have to go down the coast, they have to go through the Gulf of America once this is all done, and then Charlotte Harbor is made an American port, and now they can take America and make port in America. But it has to happen at Charlotte Harbor, it's the only place, no other place, Charlotte Harbor, Southwest Florida.

CaptKyle: And that was a part, and this was all a part of the setup by the longshoremen, the longshoremen, and having to transfer those trusses back into the country away from the,

Robert: Right. So the reason it has to happen at Charlotte Harbor is because there's a road called King's Highway in Port Charlotte, Florida. King's Highway goes to King's County, Brooklyn, which is Grand Jurisdiction. When it dead ends into the Tamiami Trail Corridor, that is the Tampa to Miami Trail, or the Trail of Tears, Okay. And that's why the Coast Guard says to Tampa, Tampa Bay, because that is theirs. So the Coast Guard's got Tampa Bay. The Navy gets Charlotte Harbor. Does this make sense? King's County makes it to the Tampa. Yeah. Tampa, Miami Corridor, which is all Florida Central, which is the country that they founded. And Florida Central is the Seminal Preserve and the Seminal Tribe never signed a Treaty which means that that land was never settled that so that's why that area right there because they have they have Tampa Bay, that's the Coast Guard they divide the Coast Guard from the Navy on the same actual borough because that borough the organization of Hillsborough county is actually out of Manhattan because the Indian word for for Manhattan is *Hill Island*, it's Hillsborough from Pasco County to Southern Charlotte County East to Polk and and Desoto is the actual borough, of Hills Island that was that is that is the virgin, North American borough that has never actually been organized, ever, since the 1830s.

**CaptKyle**: You know, this has been such a fucking word salad to try to figure all this shit out, right? It's no purpose, you know? It really is, and it's been so difficult. But, you know, after that makes landfall, right, and gets established, then...

**Robert**: So two things have to happen right after. Once it happens...

CaptKyle: So let me...

Robert: Go ahead, go ahead.

**CaptKyle**:: Before that. So once that happens, then we have the bank—

**Robert**: No, no. That's what I'm saying. Like, there's something that has to happen first. Once that happens... (**CaptKyle**: Okay, tell me what happens.) Once that happens, with all the Judge Advocates there, there has to be an individual who is appointed with the authority to assemble the Grand Army of the Republic. The Grand Army of the Republic is parked in Brooklyn, New

York at the Grand Army Plaza. So the Grand Army, the American Grand Army of the Republic must adjoin all five Judge Advocate Generals into one unified American Grand Army and then activate all American, Veterans as militiamen and put them in formation as the Grand Army with the regulated Militia. That has to happen first. Because you have to make the Army American and not U.S. Then you send the American Navy to the Grand Bank because now they're an American Navy, and then they come back.

CaptKyle: Okay, so yeah.

**Robert**: That has to happen first. So there was one part we skipped. But the Grand Army is parked in Brooklyn at the Grand Army Park. And right next to the Grand Army Park. (CaptKyle: I was already at the park where we were actually making landfall.) Oh, yeah, because there has to be ceremonial. So, like, when they go into Sarasota County, the Marines have to make, is it the Marines? Let me think. It's weird, because I'm trying to, like, figure out... like, trying to put it in my head. So the Coast Guard has to make landfall, I think, in Tampa Bay. They have to make station, right? (CaptKyle: That the station in Tampa Bay, but then the Navy has to harbor in...)

**Robert**: No, no, no, we have two more. We have other ones that have to go first. The Air Force has to do a flyover, in Sarasota County. The Marines... (CaptKyle: So isn't that the same principle of what they did when the military took the field?) So the Marines have to make landfall in Sarasota County, in Englewood, Florida, in the Special Equity Eistrict of Englewood, Florida, on the Sarasota County side, the Marines have to make landfall. The Army has to come in by helicopter with the Tribes, because that's why all the Army helicopters are Tribal, they have to come in with the Tribe and deliver the Tribe and stake the flag in Sarasota County. And then the Navy has to come into Charlotte County to divide commerce into two. Maritime goes to Tampa Bay, Navy goes to Charlotte. And Army and Marines go to Sarasota, all on one borough, all on one North American jurisdiction, and when they divide them up, they are all actually now, now the Coast Guard gets separated, that's the Public, because they're up in Tampa Bay. Today, the Navy is down in Charlotte, that is commercial, the Army and the Marines are together in Sarasota County, in the same Special Equity District, establishing General Law and Equity Law, and when the Community comes together at the Convention, after the flags are struck, the Grand Flag is raised, where they land. That initiates the Grand Congress. So this is like crazy. But everything is already set up to do it. It's ready to do it. It's crazy. (CaptKyle: I mean, this is already because actually, they already did it.) Well, they did that part. That was the part to get them into the Gulf of America. (CaptKyle: They did the exact same thing.) So that was to get them in the Gulf of America, now we're getting them into America, like real America. But you got to get the Seminole. So we tried to tell, we've been reaching out to the Seminole Indians, and they parked an American Bar Association attorney in front of us, which is a Foreign Knight of a foreign country. And the attorney's blocking our access, even though it is an American religious issue, a Tribal issue because what the intent is is that we're going to offer the land, the Land Jurisdiction, not the Borough Jurisdiction, because that's the official North American Jurisdiction, but the land record is going to be offered to the Seminole Indians. The Seminole Tribe, and then we're hoping that the Seminole tribes will all unite on the land record and the


Tribal Nations will be the land administrator for all the lands. So we're basically giving the Tribal Nations back the entire land jurisdiction, taking it away from the counties. It'll go to the Tribes. And really, honestly, they're the best at preserving nature and caring for the land. So what better, organization to give it to? We have to give it to somebody. It has to go to somebody, right? So then that's part of this thing is we have to figure out. The other thing I figured out, and this is how.

I came to all this, the word *seat*, and seat of government. You know how they have to set up a seat? What's the seat of government? Seat, is not a chair. Seat actually means, It means *Sea*, *Earth*, *Area*, *and Territory*, which are the four basic jurisdictions that you need to settle an area, a part of a territory. Territory is the Borough - *Area is the Land*, *Earth is* the property record or the *Public Property Record*, and *Sea is the* Commerce, or the *Consumer Commerce* side.

CaptKyle: Okay, so now we've kind of walked into this and things that are happening, they are going to happen whether people like it or not, the way it's going to go down. And it may not all go down in front of any of you, so you may not even know, any of it happens it don't matter right okay um these are the things that are happening, right okay, so how how do we at this point because we're at another state (Robert: yeah we're at the next like we're hitting that next level) where now we're there yes and then you're gonna you're gonna continually start you know frog hopping on down the road right because that's the way it works right and so now we have two different financial, or we actually have three, different financial things that are happening all at the same time with this because we have an actual Trust that, was the original National Trust which is the bank which is 150 trillion dollars (Robert: that was Hamilton.) and then that's still sitting out there that's going to be a part of this but then you also have that's a part of the national, that's been parked offshore that needs to onshore. That's a part of this, right? And then we also have, which is the sovereign fund for the American people itself and how that fits into both of these trusts, because there's a money trust and there's an endowment trust, which is minerals and wealth. And it's just like when it was set up with like the UAE, they actually talked, they brought these people in on it, establishing how this is all going to go down to the way that they did it there on how they have taken their wealth of their country and shared it with the people of their country, right? Their nation. And so how are we going to begin to transfer and to operate within this new construct because we already know we're going to get a new financial system and one that's based on actual real value, none of this fiat crazy paper shit. And that has to go away. And that's what we're in the process of doing right now and establishing that. And another part of that is Canada coming into North America because people, it is going to happen. (Robert: Well, yeah, because we're uniting the Kingdom of North America again.) Yeah, well, I just want people to understand that it's going to be one.

**Robert**: Right, it's going to be one kingdom. I mean, I said that before. We're going to have it. It is a Kingdom, North America is the eighth kingdom. (**CaptKyle**: I know, and I've been telling people it's been a kingdom too and they get all bent out of shape. But that's just the way it is. Well, that's just the way the jurisdiction is structured, so you have to accept it because there is a level of jurisdiction, that operates at kingdom. And it's only one kingdom. And if you're not a

kingdom, you don't talk to another kingdom. You talk (CaptKyle::there's seven, right?) Well there's actually eight kingdoms, according Thomas Payne, in 1750, Thomas Payne wrote a book and in that book it says there are eight continents, because they included Antarctica. (CaptKyle: Well let's leave that...) But the Bible says there are seven and there will be an eighth. So Thomas Payne's writing actually matches the Bible.



CaptKyle: But let's just see how that plays out.

**Robert**: So here's the other side, you're asking you're asking really good question.. (CaptKyle: we're pretty damn close.) because we understand it so here's here's where, it's gonna hit like like home like give your you and your house right so remember I said that we're still looking for that organization that's gonna that's gonna be that, that mechanism that rides in right that's kind of going to be the part that like kind of pushes everybody into that that current right once we decide who that organization is and we have them set up the way that they need to be set up and we're hoping that we're going to get that answer in the next day or two then what's going to happen is and this is already happening in Florida, in Florida because of of the jurisdiction because of where it is because it's all going down to Florida and we know that for a fact we have everything lined up we know how to do it we know what to do we know who has to be there so once we have that done what's Florida right now is reorganizing uh through one organization, we don't really know how it's if they're the organization yet we're still kind of up in arms, but there is a good relationship for the organization and we're still kind of up in arms but there is a good relationship, with this organization's Florida area so they are reorganized, into regions and they are getting ready they're finalizing the documents to actually legally publish their legal notice of a Territory Public Hearing for a Council of Territory in their County for the counties that are actually

affiliated, so that is happening in Florida right now, and the Florida is dividing up into regions, there will be five regions, to begin because that will create a Regional Council of Territory for Florida, State Territory, so we don't know about the other states because we are still trying to determine what national organization is going to be selected to be the the streamer that can be a part of that. connects. And then once that's connected, basically they'll start to reorganize into their regions and then legal notices will go out. They're going to have their public hearing and

then they're going to elect a Tribunal out of who shows up for the public hearing. Hopefully there's a Veteran there. The veteran sponsors the tribunal or is on the tribunal. And now you have your council, your County Community Council of Territory, which is in the Borough. And that's how we get this connected. Once then they get registered. So as it comes down, as Trump and his people are doing their thing at the top, we are facilitating that thing at the bottom and we are merging them closer and closer until they end up in the same room because the people have to do the bottom and they can only get so far. We have to meet them we have to agree we have to connect so they're doing what they're supposed to be doing we are now doing what we are supposed to be doing. I hope that we have an answer tomorrow or the next day as to the rest of the nation being divided up into regions getting their legal notices out I'm the International Bar Member and I'm the Ordained Minister so I can sponsor those organizations to get their territorial stuff done. My ordination was specifically international, (CaptKyle: WellI would say Robert you need to get on the phone...joking.) Well listen, I'm one person. I'm one person, okay? So my Ordainment, and this was this was crazy because we found out about the boroughs, right, we found out that this is North American Territory is where the official record is is where, the Veterans record their DD214s that is, where Common Law happens, we found all this out, (CaptKyle: Yeah, we were talking...) and then it was crazy because then I found out my Ordainment, my International Independent Ordainment, was to the North American Continent, so specifically my Ordainment my mission, from how I got ordained was to declare me an International Independent Ordained Christian Minister in North America on the North American continent, which is the exact jurisdiction where you have to put the Ordainment to ordain the jurisdiction at law which is the law we're looking for. So it all lines up, (CaptKyle: yeah because everything comes under God, everything falls under a um, spiritual premise everything does all along...

**Robert:** We're not arguing that, but we have a judicial, ... (CaptKyle: No, I'm not talking about that. I'm just talking about to the people so that they understand that this is where it all comes from. And there's no getting away from it. I don't care if you're atheist or not atheist. I don't care.) Right, it doesn't matter.) You're going to figure it all out eventually anyway. It doesn't matter because America was built as a liberty, religious liberty realm. So it has nothing to do with that.) Separate church and state and all that crap was a bunch of... And the funny part is, and I say this to people, I'm like, look, I'm an American veteran. My job was to fight for two, really two things. One, was the facilitation of our commercial sector and our trade relations to make sure that they were not compromised or destroyed so we could continue commerce. Two, was to protect the rights and liberties. of individuals and their freedom to believe, but it was not to facilitate people's beliefs to subjugate other people. So I'm an American Veteran. I'm neutral. I don't care if you pray to a pizza box. Go in your closet and pray to your pizza box, but do not come out in public and pound everybody with your pizza box. Do whatever you want. You are free to do that. I am politically neutral on that. Do whatever you want. On the other side, merchants and profiteers are not going to have slaves. That is unacceptable. And that shit's over with. So don't beat people up with your religion and make it a weapon. Do not think that you are going to subjugate human beings into slavery. Those are two no-nos. (CaptKyle: Yeah, and that's not... And the way spirituality, the way God's moving right now, I can tell you that right now, is that...

You're not going to have to, because God's revealing himself in all the ways that...) We agree with that, but we have to understand, when the military says we are apolitical, we are not saying we're apolitical as in we don't have an opinion. We're saying our duty is to make sure that these people have these fundamental human things, and that these people are not going to enslave, but are going to be facilitated to expand and exercise technology and expand their intellect and make new inventions and all that other stuff. We are sitting in the middle. You can have your religion, you can have your riches, you're not going to enslave them, and they are not going to beat you with their religion. That's not going to happen. That's what neutral politics is. There's a measure of both. CaptKyle: Yeah, I agree with all that. Yeah. And it's just that everybody has equal measure, equal rights, and you're not about to force those.) That's right. (CaptKyle: You're not walking on slaves. You can do whatever you want in your own private house. You can do whatever you want to do. It's your deal, you know? And that's the way it ought to be. That's a part of being sovereign, and that people are going to have to learn how to be sovereign, actually.

But they're also going to have to learn how to be accountable. (CaptKyle: That is a part of being sovereign, though.) That is a part of responsibility. Civil liberty is a responsibility just as much as it's a right. (CaptKyle: Absolutely. That's the whole thing is. And that's where, like, the insurance companies and all that, that's all a bunch of free stuff.) Well, it's slavery. It's enslavement. (CaptKyle: And all that's going away. And I told people this a long time ago. Because you're self-insured. You're responsible for your own actions. And that's the whole thing is. It's about taking care of your financial responsibilities to be responsible for your actions and to be accountable for your actions, no matter what you do. Right. And that's where we have to learn those things. And that's the way things used to be. And they got, you know, kept giving up more and more of those, you know, responsibilities and rights to other people. They took more and more advantage of those and they just started taking them.) So it's and I think there's something that has to be said, you know, it's, you know, let's let's go back to like why this has to go down where it is. It is interesting that the actual owners of the of the Brotherhood, right, the Trust are in Charlotte County. The actual public hearing that took place was in the city of Punta Gorda. So that all happened right there. Unplanned. But it's all right there. The petition and summons to the Marine Corps and the Army happened right there in Punta Gorda, Florida, in August. And all of a sudden we find out that is where the Navy has to make port. So as crazy as it sounds, everything lines up to that location. (Kelly: Do you guys want to talk about the trust at all? Well, we're in on an hour and a little over an hour now. So I know you.) (CaptKyle: So we have talked about the trust. We did talk about the two different trusts.)

**Robert**: Well, this is the actual American National Trust. That's the trust that we're talking about now. The owner the organization that owns the Trust that I represent, right? That I'm that i'm representing, that organization is actually based out of Punta Gorda, Florida, which is where Charlotte Harbor, (**CaptKyle**: okay so i think what she's talking about is she's talking about the sovereign fund and that's being established on a upper level, not where we're at right here where what we're what we're talking about need to be done from the bottom right that's being established okay. We can look at the um uh debt clock, right? That's got 186 trillion freaking dollars of,) No it doesn't. Does it say that? (**CaptKyle**: Yeah it was 186 trillion, yeah.) That's

hilarious. That's hilarious, they added it. (**CaptKyle**: So, that's what I'm trying to say, is that this money is in those stolen assets. What is it actually, Kelly? They got a name on it, right? It's undeclared assets or stolen assets. (**Kelly:** Yeah, and it's insinuating it belongs to the people. I just forget what the title is. It does.)

**Robert**: So, let me tell you what it is. It's funny because I told somebody we're 100. I said, right now, the American People's Republic is worth, I actually said this, \$180 trillion, and somebody said, how is it \$180 trillion? I said, because there's \$150 trillion in the national bank that goes back to the Hamilton Bank. But the \$36 trillion or whatever, is actually the money that is owed by India and the European Union in loans from the American people for their federal government, that has been dispersed. So India and the European Union is the other \$30 something trillion dollars.

**Kelly:** I just pulled it up. We've got recaptured assets and that's at 7 trillion, 529 billion, 873 million, and then total hidden wealth \$169 trillion 518 billion okay 170 trillion total hidden wealth.

Robert: I don't know where the 7 trillion dollars is but I can but but I I pretty much lasered down that the federal government they kept saying it was a loan they were loaning it they were like it was a loan. What they were doing is they were, borrowing against the \$150 trillion that's how they were getting money out ,well now because everything's upside down, the American people have America's returned to the world stage America's back and we are up and we're standing up and we're getting our stuff in order, those loans from the federal to the federal government which is a foreign country, those loans are owed to us, and if we call them due they have to pay and this is why we have to stay away from ideas that we can do whatever we want we're the only one. Our participation in the world stage is what facilitates them requiring to be honor those loans that they took out.

CaptKyle: So, everybody's playing on this playing field, and that's just the way it is. And we know that.

**Robert:** And we have to recognize that everybody's playing.

**CaptKyle**: Everybody's moving towards, we're all moving to the same freaking endgame here. And that's everybody.

**Robert**:: You know what the kicker about America is that's so important beyond every other nation, people throughout history? Do you know what it actually is? *We do not want to conquer everybody else's country*. We legitimately do not care to go over and conquer Asia or to go down and conquer anybody else. We have it bred into us that we don't want to do that. And that is the change.

CaptKyle: As a people.

**Robert**: That is the difference.

**CK**: Yes, I agree with that.

Robert: Everywhere you go back through feudal systems and everything else. The power was structured a certain way, those people would go conquer other nations and countries and whatever. The American people have no interest in going and conquering South America. We really don't want to do it, we're not really interested, it's just not our thing. And that's the difference about America versus other older, much older countries and stuff like that. We just... (CaptKyle: Because that's how, if you look in history, that's how they all did, they were all...)

CaptKyle: So, back into the sovereign fund, trust, so on and so forth. So, the sovereign fund itself, from my understanding how it's going to operate, is... It's basically just, as it says, a sovereign fund for the people and how it actually operates. And so when you take the monies that's owed to us, that's a part of the actual sovereignty of the people, right? That's put that trust, now that trust can be dispersed to the people, right? However they're going to do it. Well, remember, remember what I told you. Five dollars in a fund, I don't care. That's not what we're talking about. We're just saying a means to be able to do it, right? And then you take the wealth. I think we should say something about that. So remember what I told you? Well, yeah. Go ahead. I'm sorry. I apologize. Go. So I was going to get into actually. So there's been companies that have actually been seized under the executive orders that are actually a part of the Treasury Department. Whether people want to know. I don't know if you realize it or not. Right. Because of the operating in violation of crimes against humanity. Yeah, those assets are forfeited. Amazon, all of these companies, basically, were actually operating in that action. They're owned by the people, okay? They're owned by the people. There's actually other companies, and I know specifically large corporations, other large corporations, oil and gas companies and stuff like that, that were also doing the same thing that actually got taken over to, but hasn't been brought out into the public, but they actually had to change their ticker on their stock chains because of it over the last couple of years. And so, just what I told you right there, I ought to be able to tell you which one it was. And so, you can move that out of the way right there. So, there's a lot of these companies that are out there, right, that actually committed crimes against humanity and were seized, all of their property seized, all of the companies were seized. They're still operating as a company, but that company don't exist anymore like people think it does, okay? And the stock market does not operate the way people think it does either, because that was a privately owned company, corporation, and it is not a free bank market, whatever you want to think it is, it's not it's completely owned and taken over because of what it's been doing, and so when you think about all of that, these companies, corporations... are still going to function for the benefit of the company, the country the people, right? And instead of profit profiteering towards a person or a bunch of freaking bankers it's going into the treasury department which is owned now by the people, it's going to be all right people when we get this established correctly, then that's going to pay out to the people just like the wealth of the nation is going to support the people of the nation all of these things, so let's it's just like where you get these the minerals the mining

companies and all of these things that are out there that are the wealth of the nation, not going to be looted by these bankers and these criminal you know profiteers it's going to be shared with the people... (**Robert**: well because it's the people because it's a people's nation state), see, yeah so now what we have is we got, all of these freaking inputs of wealth, right, to the sovereign fund of the people so with this is why it's multi asked it's got so many asset aspects to it people it's not just cut and dry now how it actually may operate in the end on how it makes payment that's what we're going to get into right here is how it may make payment to everybody, but how much gets put into it is there's a lot of things that are being put in ...

Robert: Well yeah because it's a brand new clean carrier that they that isn't all jacked up and there's like these nefarious cubbyholes and all this other stuff in there. So what's what's most likely gonna happen and you heard me talk about Florida's being divided into five regions right they're gonna have in each County where they're gonna have a public hearing they're probably what is it I would say, by less than the end of the week they're gonna put out legal notices of public hearings at the counties that are actually, organized in Florida so, They're going to put out a legal notice notifying that there is a council, a public hearing for a Council of Florida State Territory, that's going to go out, and whoever goes there, they're going to elect the first Tribunal. That tribunal will act as the council for that county provisionally, okay? So when the system comes online and it's at a County level, whether the county is turned over to the public, is turned over to the Tribal Nations, which is our hope, or there's another judicial mechanism that is under the Coast Guard, is put in that mechanism. What's that? (CaptKyle: To facilitate that.) To facilitate that, because Coast Guard will have overview of all public judiciaries, right? Because they're going back the way they should, and the Coast Guard is our Maritime Jurisdiction under Article 3. So hopefully it's the Tribal Nation Courts that are working with the Coast Guard, right? And then they'll facilitate the public. Well then, they will contact that tribunal, and we're building a Register, to give to them and say, here's who we have registered, here is here are the contacts, here's this, and that is who that Community decided provisionally, to have. So then, they get the register, they have their stuff, they have their contacts, and then they can start to make those connections because they've already got a place to go because they've already got a provisional Council in place. And then they can start to get the Counties really organized. For real. And start getting that stuff, General welfare stuff, right? Because it was called General Welfare. It was called General Welfare. It's because it was held at General Jurisdiction, which is the highest jurisdiction, and it was to facilitate your basic necessities, shelter, food, water, communications, cell phones, stuff like that. And then that community, through Common Law, will decide what's General Welfare, and then they will pass law. That law will be certified by the Tribal Court, and then it'll be authenticated by the Coast Guard, and it'll be overviewed by the Navy Admiralty. So now you have an Observer, you have an Authenticator, you have a Certifier, and you have an Administrator. (CaptKyle: So that would be how the facilitation of the potential funding...)

**Robert**: That's how, yes, (**CaptKyle**: Because we're touching all the stones, down here to down here, okay you gotta go through the four parts and this is all ready to be like poured out on everything because it's a lot of people right right it is.) Yes, so I submitted, a provisional American Constitution (**CaptKyle**: So we are trying to establish the channels for that that

umbrella to actually operate in, right?) Right. But that can't happen until the Convention is Seated and the Judge Advocates Generals are stood at Convention and they are unified, informed, into the American Grand Army (CaptKyle: and that's what's being worked on now.). That's what we're trying to work on now. So there's like multi-faceted and we're trying to get this one organization, or the organization that's going to act nationally, and get these legal notices out, because it has to be done by legal notice, that that public hearing has to take place. That's the proper way to form this stuff. And we have to make sure that we are doing it the right way. We have gotten into this mess by not touching every step and just saying, well, it's no big deal. No, it is a big deal. (CaptKyle: Yes.) We have to touch every step because we do not want to end up in this situation again. (CaptKyle: And every I has to be dotted, every T has to be crossed, and you can't leave no freaking potential periods not in place.)

**Robert**: Correct. (CaptKyle: This is a once in a lifetime situation that is why it's not being rushed and it is being done meticulously from the top down and from the bottom up now, right?)

Now here's what's fascinating, because we're going to need a new National Universal Village, right? Because we're going to Universal Law, which is our American Ministry, right? So when we were looking around the map in the Borough of Hillsborough, we realized that there are four Counties that converge perfectly, and the Counties were *Hillsborough*, going from Coast Guard, which is *Hardee County*, it's the it's the upper the Northwestern tip of Hardee County, the Northeastern tip of *Manatee County* the Southeastern tip of Hillsborough County and the Southwestern tip of *Polk County*. (See red dot)

Now what's fascinating, is, is in the Book of Revelation it says that there will be four beasts, and those four beasts one will have the face of a *lion*, and a lion eats hardy, correct? One will have the face of a *cow*, while a Manatee is called a sea cow. One will have the face of an *eagle*, and Mc Dill Air Force Base is also where JSOC (Joint Special Operations Command, a sub unified command of the



United States Special Operations Command (USSOCOM)), is which is the eagle, and one will have the face of a *man* and Polk County is named after i believe, James Polk. So it was great I'm like wait a minute, this actually lines up, because we have to have a Universal Village to establish, our universal burrow. (CaptKyle: Well, that would make things Biblical and actually, you know, some part of the Bible actually, you know, actually is right.) It totally, I'm like, wait, it's a sea cow. It's this cow, it doesn't say what kind of cow.

**CaptKyle**: So, all right, so this is something that we need to stay in contact over the next week or so, how you're, you know, how this is transpiring, so on and so forth. And there was a good, this has been a good talk because we've gotten a lot of information.

**Robert**: Yeah, it's been really exciting. Like last probably week has been like, holy crap. Like we are literally, we are, this can go down. We can do this, like this is real. We are not, we can do this and I would like to have it done, honestly, at least have the first phase done before June 21st. And the reason is I would like to have the Land Record transferred to the Seminole tribe, and the Seminole Tribe is about to convene this massive convening on June 21st, and it would be great to have the Seminole Tribe there and they get to unite all of the Native American tribes on the land jurisdiction that they are now the Administrators of.

**CaptKyle**: Yeah, and that would be really good as far as the potential, it wouldn't be reparations, but it would be...

**Robert**: Listen, we all got lied to. The bottom line is we're all lied to, we're all bamboozled. We have got to get this done.

**CaptKyle**: Yeah, but I mean, what I mean by that is... is that the Indigenous People really got fucked over.

**Robert**: Oh, they did. They absolutely did. They got put on their...

**CaptKyle**:: They got imprisoned. (**Robert**: Yeah.) In an open world, they got imprisoned, right? So, and then slaughtered. But it would give them, the dignity back that's deserving, and it would give them the...

**Robert**: Well, it would give them their place that they really haven't, because of the federal government, they really haven't really had a part of. But the reality is, let's take it from a non-political position. The Native Americans are far better at taking care of the land and preserving it than any of us are. That's the fact.

**CK:** Because they were spiritually... Right.

**Robert**: That is just a fact. They are just better. Why would we not give it to them to administer? (**CK**: I agree.) I mean, as simple as it gets, they're just better at it. You know, it does. It gives them the honor. But they are just, they are the best for the job. Because the key is to put people in the best position to be successful and the Native Americans are the best at that job, period. So why would we give it to whoever's the best? (**CK**: Yes, I agree.) That's the way I look at it. That's the way I see it. I would like to say that that's what's going to happen. But until that Convention is convened and these details are worked out, nothing happens. I'm telling you what I think should happen I think the Native Americans are the best going forward, and in perpetuity for that particular thing, they have shown that they care about a more than anybody.

**CK:** I agree, I agree with that. Hey Kelly do you want to ask us a few questions before we um, rip this thing off because we've actually had a really good conversation.

**Kelly:** We really do have a lot of questions so let me just kind of scan through them.

**Robert:** It's been a great couple weeks like you've been in a tough spot and i've been worried about you it's been lingering but um it really has been a crazy couple of weeks. [Chatter about TikTok account removed by scribe, refer to audio]

**Kelly:** There are so many questions about this real ID. People are so up in arms about this. The first is from Claudia. She's one of our admins. She says, "Hi, Bob, thank you for all that you do. Thank you to educate us. I was. very intrigued by what you said about the real ID, that it was a way for the military to know that we are human, but wouldn't they be able to determine that in other ways from technology that we are unaware of? The chip in the real ID is concerning to us because it's tracking people. What is the reason for the chip?

**Robert**: We have to approach this as abandoned colonists who have been in isolation for a really long time. Right now, our education and our ability to be trusted is at a minimum. We have a perpetual habit of making bad decisions and we have a perpetual habit of making bad decisions and to get the system back online we are going to have to for at least an extended period of time sacrifice some of those privacies, some of those liberties that we want so that maybe, a generation from now that kind of trust will come back. The way that they've done it, from what I understand, is they put a layered security system in, so you are going to be tracked. You're going to be tracked for reasons that have to do with getting the systems transferred and getting them up and running. That tracking is really going to be focused on individuals because, let's think of it this way when they let's say that a a Interpol because Interpol is International Police. So let's say that an Interpol warrant is issued for a public officer, right? Because they were involved in this the human trafficking, let's use human traffic it's good stuff, When that Interpol warrant goes out, because of how the system is set up, that individual's ID, their passport, their bank accounts are all going to be locked in, and they're going to be able to track that individual wherever they are in the entire Western Hemisphere and go get them. Okay? We have to accept some latitude right now for that to happen. That real ID system is being ran by the military. We have got to put some trust in our military that has been offshore for 100 years.

CaptKyle: But that's what's happening, Robert, is the people that are out there that are talking about it, they're talking about it as the evil, bad people are still going to be in charge, and that they're going to be using it to come after us, okay? And that's the way it's being, you know, put out there to the people. And if that was the case, that would be scary as hell. But if that was the case, me and you wouldn't be having this fucking conversation right now either.

**Robert**: Well, that's true. And let's turn it to the other side. If you have your Common Law Court, and you have your courts where you are, right? And that information gets to someone that tries in the government that tries to nefariously do whatever to it. And then they try to issue a warrant. Well, guess what? Now when the system is set up right, they have to not only get through, let's say it's at a national level, they not only have to get through the State Council to get jurisdiction,

they have to get through the County Council to get jurisdiction to get to you. Because that County Common Court. is the highest jurisdiction. That's where the ability to pardon comes from. So even if they did do it, and they did nefariously do it, and you proved that there was a violation of your rights, they issue a declaratory judgment in the Seventh Amendment, you're pardoned, you're pardoned. That's the end of it. That's the law. Because this is the highest law. So...

CaptKyle: But that's what people haven't been privy to. (Robert: Yes.) And this is the fear that's out there, because, you know, people still are afraid. (Robert: Because we haven't been able to defend ourselves.) This might go down the way, you know, they're not assured that it's going to go down the way that we're saying it is. But I know for a fact that I would not, not be here alive today, period, period, if the... If... If the... White hats were not in complete control.

**Robert**: Yeah. So, so, it's... (**CaptKyle**: Because I was on a, I was on a list, I'll just put it like that, that back in '17, I would have been taken care of, that would have been eliminated.) Yeah. I wouldn't doubt if I was on the same, but we have to understand, the law... (**CaptKyle**: Actually, I showed Kelly, I showed Kelly not long ago, remember that list I told you, Kelly, that I was on a freaking, I was on a list, and it was from doing a freaking search, and it pulled up that I was on a freaking, I was on several lists.) Yeah. We have to understand, it's not what information they get, it's the ability to defend yourself, when they exploit the information is where the power is. (**CaptKyle**: Yes.) Let them have everything. Yeah. Now? Oh, you made that accusation? Prove it. Come on. We got a court over here for you, Mr. So-and-so. Prove it.

**Kelly**: Okay, here's the next question. "Thanks to all of you for what you continue to do. I have so many notebooks to try to keep track. I now have added a Robert Kraft notebook. (**Robert**: Sorry. I'm sorry). Can you please explain how this does or does not tie into the James Geiger and or Tim Turner Republic? I forgot his name, but there is a high-ranking retired military officer who acknowledged he was from AZ meeting with other high-ranking retired military officers stating they reviewed all the documents that this Republic presented to them and they declared this Republic was the real deal." Do you know anything about that Robert?

Robert: I do. I do. I don't want to get into the whole, uh the organization is called The Republic for the United States of America. There's a version of them that's called Re-inhabit, the organization, is it has there are some this is what i know about and if somebody asked me like a month ago, I would tell you I really don't know that much about them I've heard of them not really um but I have I have um come in contact with them and we've had some conversations um i actually had a direct meeting with Tim turner the other day uh so um I have I have been in contact with them, Because I've been searching for an organization to drop on our trust as the carrier to carry into the new republic, right? Because it's easier, you know, this is the First Amendment. The First Amendment is about assembly. We are assembling the pieces and parts that we need, the way we need them, where they need to be, so we can put it together. Right? It's assembly. So, in that, the organization that I have did not span a national footprint. We went through the judicial side and built the judicial mechanisms to be able to put that stuff on it. So, I

don't have that footprint. So, I've got to find something that works the best. I have been in contact with these people. They are not excluded. The only organizations that's been fully been excluded is the American States Assembly, they are not going to be part of it.

**CaptKyle**: Robert, so remember when we were talking about the Washington and the organization that was kind of exposed and they were this is what they were doing at this same kind of national level that we talked about a couple you know a month or so ago? (Robert: Yes.) Same thing same thing you were doing but on a much greater scale, right? Remember so how does they potentially fit in?

**Robert**: We haven't gotten that far yet, so i don't i don't know really and this is something that that came out because I got questioned, because there's another part of an organization that contacted me and I told them I said, at the county level where all this is going on, stuff's getting streamlined your organization is going to be, represented in that county, you will not lose your national, or whatever footprint, you're just coming into a linear platform for the transition, but at a base your whatever, organization you have you're staying with that's just not the carrier that's going to walk you through, if that makes sense.

**CaptKyle**: Yeah it does, I just wanted to bring that into the mix for the people with them asking questions.

**Robert**: So I don't I don't know. I have been on the phone, listen in the previous two days today two days, prior to today, I literally spent 14 hours on the phone in two days.

**CaptKyle**: Wow man that made it was painful. (Robert: it was painful so, till...)

**Kelly**: The next, question from Amazing Grace. "How is this new structure going to be communicated to the people and when? Trump wants to have a military parade on June 14th. Does this play into the structure of what you are describing?

**Robert**: I don't know. Number one, I need to make you clear. Our organization is operating in the North American Territory, the continent. That is not a U.S. territory. So when you say Donald Trump, you're talking about the United States, not America. Okay? So we don't have any contact. Yes, the North American continent, America, we are not allowed to collaborate in this process of building this church, American Church, we are not allowed to collaborate with the Executive Branch of the United States. We have to have a separation of powers and authorities. We're doing things for the American people. This is the American people. It is not the Executive Office of the president.

CaptKyle: And there's so many things going on simultaneously that are trying to bring all of these facets together, but also separate.

**Robert**: Right, we have to make sure we stay in our proper lane.

CaptKyle: Everybody has to stay in their own lane, but everybody's got to get to the end of the freaking race.

**Robert**: Right, correct. And that's the key is to get us all together in the same direction. In this, across this finish line. So that's, that's the answer. I don't know. I honestly, I don't watch TV and I don't, I don't really pay attention to new stuff. So I, this is the first I've heard of Donald Trump having a parade. I didn't even know about it.

**Kelly**: For the 250th anniversary of the army falls on his birthday.

**Robert**: Oh, well there you go.

**CaptKyle**: And he plans on having a big celebration, big, huge military, military, 6,000 military people. So it's supposed to be a big thing, right? And we're not going to do anything that doesn't have multiple reasons in the background and not just what's right.

Robert: And there's something that needs to be said. We, we are not going to lose because the Grand Army gets formed. We are not going to lose the United States army. We're not going to lose the United States Marine Corps. We are not going to lose the United States Air Force. We are not going to lose the United States. That is not going away. The Grand Army is to attach the function of the American National Army, or the American National Armed Forces versus our U.S. Armed Forces so once for the domestic that includes the militia, one is for our U.S. representation, which includes our national defense system, because we have to have a national defense and a foreign defense and we have to have all enemies without and within, foreign and domestic, this sets that pace for a domestic and a foreign where the enemies will be.

CaptKyle: Alright Kelly... (Kelly: let's do this from Joe Patriot, "Can you ask what is the breakdown of regions, in Florida, and is there a way we can get involved?"

**Robert**: Oh, you know what? I do have a Public Information Officer. I will, it's Patty (Cummings) Hatfield is who it is. Just point her to Kelly and then she'll put it on her website. Patty (Cummings) Hatfield has agreed, I don't know if anybody knows Patty (Cummings) Hatfield, I talked to her the other day. (Kelly: Yeah, I know Patty.) Yeah, Patty has agreed to be the Public Information Officer for this process, I forgot to say that, because we have a financial person, and we have an archivist, and Patty took the position of Public Information Officer, and we are still filling out some of the other positions that as they come along. But yeah, so Patty (Cummings) Hatfield is and I will get you contact information.

**CaptKyle**: Do you have somebody that can fill a professional shit talker? Because I can fill that.

**Robert**: Well, I got myPublic Information Officer, (**CaptKyle**: I was just kidding, so, um... I take care of myself.) As far as the regions, you would probably... The regions are going to be divided

into... Right now, we're setting up five regions. And I think they're the original, like South Florida, West Florida, East Florida, North Central, like Jacksonville area, and then the Panhandle, I think, is the way it's set up. If you look on the map, there is some, we used one that was already previously been accepted. We're not reinventing the wheel. We're going to take what works for us and use it, and we're going to disregard what doesn't work. So we're not here to just reinvent things. But if you do some maps on Florida regions, It popped up pretty quick that it was the five regional setups based on the volume of people we have, because I think we're at 42 counties. I believe it's 42 counties in Florida.

**Kelly**: Okay, last question is from Frankly Speaking. So all of that process that Robert outlined, does it have anything to do with the ability of the entities involved to re-evaluate the currency? Who or what controls the monetary changes for the U.S.?

Robert: Yes, until the National Central Bank. Back inside America, the nation, the National Jurisdictional Bank cannot, the National Global, this is actually a great example of why when you say Universal Law, and then you say the Vatican, I'm like, wait a minute, it's the Vatican, they signed a treaty, now it's Judaism and Islam, there's been collaboration with the Greek Orthodox Church, and people are like, no, no, no. Well, here we go. Take that concept, universal law, and bring it to national. That is the Central National Bank. So when you say Central Bank of Iraq, for those of you who have dinar, that is Central Jurisdiction, that is Manhattan, that is Grand Central Station. Are we talking about Grand? Grand Central Station. That is Manhattan, that is New York City County, the financial district, all the way down to Wall Street. Central Bank of Iraq is from there. The bank that you're talking about for revaluation has to be put at Grand Central jurisdiction, so it is the Grand Central National American Bank, for revaluation. That's how it works. That's why it has to come into the American National Republic so it can be at the American National central location, which is Manhattan.

**CaptKyle**: So this is why all of this is being established. Groundwork is being established for the Treasury, the Monetary Fund, the finances. All of that's being done at a high level so that when we actually have it in place, all you got to do is plug things in.

**Robert**: That's right so and that's that's how it works, but that's the hard part that we didn't understand. We're like, "Oh Trump..." No, no, no; we, it is our our stuff, we have to do our part to make those connections, because if we don't do our part to make those connections they rule the connections, but if we do our part to make those connections and then they do something nefarious that we don't like we break the connection, because we're in charge of it. We put it there, we can take it away. We who giveth, can also take it away!

CaptKyle: Right. All right my brother it was awesome yeah it was great talk as usual uh we'll do it again, let keep in touch with me and um what's going on this week and then also get the information over to Kelly and then we'll post it for your, Public Information Officer and all that stuff and that people can do the things that they need to and keep giving them hell, brother. (Robert: All right. You take care.) Yeah, thank you. Talk to you soon.
